4 point: Donald Trump is US President-elect, a president of the first economy in a world. He has tremendous influence on media and the whole world.

Surely the expectation of profiting is based on the efforts of a third party. Donald Trump's \$TRUMP meme coin has caused a stir in the cryptocurrency world, reaching a jaw-dropping market cap of \$14.5 billion within hours of its launch.
